

ORDINANCE NO. 2005-01A

AN ORDINANCE ESTABLISHING AN ISLAND PARK AREA OF IMPACT IN THE UNINCORPORATED PORTION OF FREMONT COUNTY SURROUNDING THE CITY OF ISLAND PARK, IDAHO; ADOPTING AN OFFICIAL MAP OF THE ISLAND PARK AREA OF IMPACT; AND, ESTABLISHING THE EFFECTIVE DATE HEREIN.

BE IT HEREBY ORDAINED BY THE GOVERNING BOARD OF THE COUNTY OF FREMONT, as follows:

1. Island Park Area of Impact Boundaries. An area of city impact for the City of Island Park is established within the boundaries illustrated on the Island Park Area of Impact map, attached hereto as Exhibit A, which map is hereby made a part of this ordinance.

2. Effective Date. This ordinance shall be in full force and effect, from and after its passage, all as provided by law.


